### Working Lunch: Networking and Member Reports, All Council Members – Andrew Mills and Rochelle Larsen

Andrew Mills and Rochelle Larsen shared their activities over the last year with the Council.

Presentation: Crisis System Improvement Program, START Services Review and Update – Stephanie Perry, Idaho START Program Director, David O'Neal and Felicia Bates, Project Facilitators, National Center for START Services

Stephanie Perry, David O'Neal and Felicia Bates provided an overview of the Crisis System Improvement Project and the national START model. START stands for Systemic – Therapeutic – Assessment – Resources – Treatment. This model is

evidence-informed and integrates community crisis prevention and intervention for children ages six through the lifespan with intellectual and developmental disabilities and co-occurring mental health needs. The START model uses a whole person perspective to better understand needs, strengths and triggers.

### Discussion: Why START services are important to the DD Council – Christine Pisani, Executive Director

Christine Pisani, Executive Director, reviewed the history of the Council's support and work towards an improved crisis intervention system in Idaho. She helped the Council understand how the Council's current work towards an improved person-centered service system could benefit START implementation.

# Presentation: START services and Person-Centered Planning – Sarah Allen, Supervisor, Charting the LifeCourse Ambassador and Person-Centered Thinking Training, Hayley Helm, Clinical Team, Person-Centered Thinking Trainer

Sarah Allen and Hayley Helm described the person-centered thinking curriculum, the Charting the LifeCourse framework and tools. They clarified their work as trainers and how these tools have been used in Idaho.

### Discussion Activity: How could DD Council Person-Centered Planning work help START services in Idaho? – All Council Members

Council members shared feedback from small group discussions relating to START model implementation on four topics. START national team members participated as well and learned about dynamics unique to Idaho. This information can help inform roll-out activities. Topics discussed included rural and urban community considerations, building community connections for individuals and teams, and how to ensure team integrity.

# Legislative Action Recommendations: Setting Priorities for the 2025 Legislative Session and Next Steps

#### **Background Information**

Council members will receive more information about possible topics for the Council to work on during the 2025 legislative session. The full Council will discuss all topics and prioritize them to create legislative action recommendations.

#### Legislative Topics:

- **ABLE Legislation**-allows people with disabilities to save money without losing benefits. Idaho is proposing to join another state's program.
- **Proposed changes to Idaho guardianship laws** these changes update the law and protects the rights of individuals who are subject to guardianship and conservatorship.
- **Direct Care Workforce Shortage** ongoing education and information sharing about the workforce shortage in Idaho.
  - Apprenticeship Model

#### **Next Steps**

During the 2025 Legislative Session Council staff would like to create an Ad Hoc Committee to review legislation, DD Council priorities and communicate to DD Council Members. Regular meetings would be set during the session to review proposed legislation. Members will be asked if they would like to participate.

Council member legislative homework and due dates will be discussed.

Council staff will host a virtual meeting on Thursday, January 16<sup>th</sup> (time to be determined at the Council meeting) to prepare for visits, review proposed legislation, and fact sheets. This meeting will be held to prepare Council members for their legislative visits.

#### How the Council Sets Priorities for Legislative Issues

The Council has three levels of involvement in legislative issues.

#### Priority One -- Leading the Way

ICDD will actively promote, oppose, influence, and advocate for programs and policies that impact people with developmental disabilities and their families. ICDD will take a leadership role on these activities, and will use these ways to do so:

- Educating Policymakers
- Grassroots advocacy
- Working with others
- Media
- Other activities, as needed
  - O Past example: Criminal History Background Checks for Guardians and Conservators Legislation Council drafted legislation to require prospective guardians and conservators to undergo a criminal history background check. We worked with legislative services to create the bill and a sponsor Legislator to carry the legislation. Staff created plain language fact sheets and promoted the issue with stakeholders, associations, and partners. Staff and Council members met with legislators about the issue and then staff testified in support of the bill during hearings (the bill passed and became law in 2013).

#### Priority Two -- Lending Support

ICDD will work closely with people with developmental disabilities, parents, disability partners, coalitions, and others to promote legislation that is helpful -- and will work against harmful legislation to -- individuals with developmental disabilities and their families. ICDD may choose to lead on some issues, or may follow the lead of others, but in general will use these ways to do so:

- Active Coalition Participation (i.e., serving on committees, signing on to coalition efforts, forwarding coalition information)
- Watch Legislation
- Communicating with Council Members
- Communicating with Policymakers
- Communicating through social media and website
- Action Alerts

 Past Example: Sign Language Interpreter Licensing – Council members heard a presentation from the Council for the Deaf and Hard of Hearing (the sponsor) about their legislation. Staff drafted plain language versions of fact sheets and informed Council members who met with legislators about the issue. Staff presented testimony in support of the bill for both germane committee hearings. (bill passed and became law in 2017).

#### Priority Three -- Keeping Track

ICDD will closely watch legislation and have a voice on issues of interest to the disability community. ICDD will watch legislation, answer questions to the Council, and provide clear information and recommendations.

O Past Example: Futile Care Legislation – in 2013 the Idaho Medical Association introduced legislation to change the definition of "futile care" in Idaho code. The ICDD Public Policy Committee was informed about the issue and recommended monitoring the legislation. Staff tracked the bill's status during the session and informed members and stakeholders through ICDD legislative updates.
